Contingency Fee Agreements A contingency attorney's fee is based upon an amount of recovery. There is no fee owed at all if there is no recovery. If there is a recovery, a certain % is applied for the fee. The Florida Bar has limits as to % may be charged. The Florida Bar requires contingency fee agreements to be in writing.
